Puppy (**IS / IS NOT**) required to be (**SPAYED / NEUTERED**) If puppy is purchased for breeding, buyer agrees he/she **WILL NOT** be bred or used for stud until at least 1 year of age and **NO** guarantee is given to fertility. If said puppy is to be shown **NO** guarantee is given as to the size any puppy will attain as an adult or to show ability. My kennel name "Goldkress Kennels" is to be added in the name on all registration papers.

Said puppy comes with (**FULL / LIMITED**) AKC registration papers, a 4 generation pedigree and health certificate. Puppy is current on shots/worming, is in good health at time of shipping is guaranteed for 72 hours for health issues, has a 1 year (from date of birth) genetic guarantee and if applicable is micro-chipped # _____. If puppy is shipped and dies or is injured during shipping I, Lonita B. Kress / Goldkress Kennels is not liable, and any recourse will be between the buyer and shipping company.

If for **ANY** reason legal action becomes necessary (either by buyer or seller) buyer is required to come to Lawrence, Kansas (Jefferson County) and will be responsible for ALL court costs, attorneys fees, legal fees and travel expenses incurred by Lonita B. Kress / Goldkress Kennels.

Buyer has until _____ (72 hrs. from date of pickup/delivery) to take the puppy to the vet of their choice for a "wellness check". If it is found at that time the puppy is sick buyer has the option to return the puppy (at buyers expense) for a full refund of the purchase price **ONLY** or to pick another puppy of equal value (buyer is responsible for shipping of a replacement puppy). If buyer does not take the puppy to the vet in the 72 hr. time frame specified above the guarantee is null and void.

If puppy should develop "genetic" problems within the 1 yr. time frame (from date of birth) buyer has the option to choose another puppy of equal value or receive a full refund of the purchase price **ONLY**. The puppy however **MUST** be returned to seller (at buyers expense) along with a letter from a certified vet stating the genetic disorder to pick another puppy or to receive a refund and is also responsible for any shipping charges (this includes airfare, crate & health certificate) for a **replacement** puppy. I, Lonita B. Kress/Goldkress Kennels will not be held responsible for any vet bills incurred with this purchase or any replacement puppy. If any puppy is returned for any reason other than health/genetic conditions there is **NO** refund or exchange.
